


Economic Growth Rate of the Kyrgyz Republic (2012-2023)

Economy Comparison

GDP growth (annual %)



The Republic has maintained annual growth rates between 4-5% consistently throughout the 2010s.



Growth Rate in Recent Years

- During 2021-2023, its average growth rate reached 6.88% per annum, recording the highest growth rates for three consecutive years since 2014.
 (5.51% in 2021, 8.97% in 2022, and 6.15% in 2023)
- GDP at the real value of USD in year 2015 therefore grew up from 5,572 million USD in 2012 to 8,975 million USD in year 2023, marking 161% growth during the 11 years between 2012 and 2023.
- Is it really meaningful numbers? The answer is yes, or not.




GDP gap has been widened rather than reduced in real terms.

Growth Rate in Recent Years


• The economy of the Kyrgyz Republic at present is characterized with

• Without special measures to speed up its growth rate, the relative size of its economy could be dwindling as time goes by vis-à-vis neighboring countries in the region.





1st Phase


- Setting the national goal

- Administrative/Government reform


3rd Phase

- Grand strategy in diplomacy




